## APA MN LEGISLATIVE & LAW CHAPTER UPDATE

The CM reporting period ended on December 31, 2023.

If you have met your CM requirements for the reporting period, you must review and sign off on your CM log before you can begin logging credits for the new reporting period. Closing your log takes just three easy steps:

- Review the final tally of CM credits for the reporting period that appears in your log. If it is correct, click Continue to Close the appropriate reporting period.
- Read the review confirmation statement and click the adjacent box.
- Click Close (Option to close log will appear in your log on January 1 of every new reporting period).

If you have not yet fulfilled all of your CM requirements, or if you have and just not logged your credits, the grace period runs until May 31, 2024. Still looking for credits? There are many live and on-demand offerings that are available. The easiest way to find opportunities is on APA's website on their CM Search page.

rly 2024 Legislative Session: The Legislative and Law Committee has been active throughout the fall in connecting with advocacy groups, industry groups, and our professional partner organizations to get a sense of the scope of legislative activity before the 2024 legislative session, which will start on February 12th. The committee will host a call with APA leadership in January to discuss what it has learned, how it will keep the APA Minnesota membership informed, and how it plans to engage as a voice for planners in the political process.





Point Access Block Lunch and Learn:

The Legislative and Law Committee hosted a lunchtime event with Sean Jursnick, a Denver-based architect (and Minnesota native) who presented on point access blocks. These are buildings of over three stories with just a single point of egress, that are outlawed in much of the country but could provide significant benefits to urban infill and can be implemented in a safe way. Smart Growth vs Minneapolis Lawsuit:

The Legislative and Law Committee secured the probono services of Iverson Reuvers, an experienced environmental law firm, to help defend the Minneapolis 2040 Comprehensive Plan at the Minnesota Court of Appeals. With this assistance, APA Minnesota was able to file an amicus brief ensuring that the perspective of professional planners around the metro and throughout the state would be considered by the judges.

#### **APA MN CONFERENCE 2023**

#### REVIEW AND HIGHLIGHTS

The 2023 APA MN Planning Conference at the River's Edge Convention Center in Duluth had a great turnout! Our conference was held Wednesday, October 4- Friday, October 6, 2023. In total, we had just under 400 attendees, making this the largest turnout since the pandemic began.

We had over 40 educational sessions and 3 mobile tour sessions that included Placemaking and Public Art as a Tool to Address Civic Issues, a go-at-your-own-pace local brewery tour, and the Ledge Amphitheater tour. Each of our mobile tours ended up being sold out.

In addition to Minneapolis hosting the APA National Planning Conference in April 2024, APA MN will also hold an abbreviated state conference this fall, tentatively near the Twin Cities metro. While likely shorter than

typical, this is intended to provide an affordable way to earn CM credits and connect locally. Stay tuned for further details as we solidify our location and dates.

The APA MN chapter is incredibly grateful for each sponsor this past year. # Mapping Prejudice Project Recipient: University of Minnesota Libraries



We give this award to a project that has demonstrated a sustained commitment to advocacy by addressing the concerns of women or BIPOC groups in its contributions to the planning profession or practice.

The Mapping Prejudice project uses innovative technology and crowdsourcing techniques to examine historic deed records in Minnesota communities, mapping racial covenants and clauses that were inserted into property deeds to keep racial minorities from buying or occupying homes. This ongoing project has shed light on previously little-known discriminatory practices and spurred ongoing conversations about necessary updates to real estate and zoning practices. It has become a template for exposing the roots of race-based housing inequity one that is now being exported and emulated across the entire country. As such, it is a vital tool for helping communities start conversations about housing equity in the present day. Congratulations to the University of Minnesota Libraries for your well-deserved award for advancing diversity and social change!


## Bemidji Parks and Recreation Equity-Based Strategic System Plan


**Recipient: City of Bemidji** 




This award recognizes a project that advances the science and art of planning, and which promotes greater awareness of the benefits of good planning.

With its Recreation Equity-Based Strategic System Plan, the City of Bemidji Parks and Recreation Department set out to produce a plan that foregrounds equity through robust engagement and a focus on universal park and trail accessibility that overcomes barriers from income, transportation, physical ability and cultural background. We felt that many of this plan's features, such as its community input map, its priority tiers, and its inclusion of maintenance and operations expenses made it an innovative, community-grounded, equitable, and implementable plan. The Bemidji Parks and Rec department has shown their dedication to improving your community through this strategic plan, and it was our pleasure to give them the Comprehensive Plan Award for 2023.







#### RESLIENCE AND SUSTAINABILITY AWARD


**Hennepin County Vehicle Miles Traveled Reduction Strategy** 

Recipients: Hennepin County, Kimley-Horn and Associates



The Resilience and Sustainability Award is given in recognition of a project that creates a more sustainable community or increases the ability of a community to recover from and adapt to shocks and stresses, resulting in it becoming stronger, more equitable, and better prepared for the future.


The Hennepin County Vehicle Miles Traveled Reduction Strategy used scenario modeling to predict future travel behavior and identify 49 different actions to reduce vehicle miles traveled. It was developed using a multidisciplinary work group and considers county-led actions and partnerships with local, state and federal agencies. The prioritization framework considers the impact of each strategy, as well as feasibility, equity and cost. Demonstrating its commitment to implementation, the county created a new Carbon Reduction Manager position to help implement the plan. Congratulations, Hennepin County and Kimley-Horn, for this great work in creating a plan that will result in more sustainable communities!





#### TDM Reduction Results

The results of the Strategies were assumed to apply to all employees within the County (1.04 million in 2040), or all residents. Sensitivities built into the TRIMMS Calculator account for the fact that some industries and types of jobs are more less likely to utilize certain programs (i.e. a VMT fee is more likely to reduce commute trips for low-income workers, but does not have as much of an impact on higher-income workers). The results of the analysis produced an estimated value for VMT under each scenario, which was translated into a percentage reduction.





# City of Rochester Unified Development Code Recipient: City of Rochester




This award is given to a project that directly addresses desires, needs, or challenges within a community, county, region, or specific geographic location. This category emphasizes outcomes and demonstrates how planning helps to create stronger, more equitable communities.

In creating the Unified Development Code, the City of Rochester sought to make their land development standards fully reflect their recent comprehensive plan goals, such as creating a simpler process of approval for diverse housing types, and requiring expanded levels of pedestrian, bicycle, and automobile connectivity at both the subdivision and site planning stages of development. Overall, the updated development code has resulted in a development process that is more easily understandable, transparent and predictable while also reflecting the current planning goals of the City of Rochester. We felt that the diligent public outreach conducted as part of creating this code enabled the City to get extensive buy-in and make some large changes to the development code. We are pleased to give the Planning Excellence award to the City of Rochester for this thorough, equity-focused update to their development code.


#### **OUTSTANDING STUDENT PROJECT AWARD**




We give this award to a student project that is original, of high quality, and transferable from an academic setting to the planning profession.

This year, the winning project focused on the Highway 1 corridor through the Red Lake Nation, taking into account community input to propose upgraded multimodal facilities along the road, as well as safer crossings and a series of pocket parks. The students undertook conditions mapping, community surveys, concept sketches, and a written report, all of which is being used to inform Tribal, MnDOT, and Federal Highway Administration planning and decision-making. We were impressed with the student team's efforts to forge a partnership with the Red Lake Nation to help make the project their own, and with the fact that they created a comprehensive process that can be used for planning on other reservations. Congratulations to this group of Humphrey School students for their well-earned Outstanding Student Project Award!

## Gunnar Isberg Student Scholarship Award: Edgar Leon Gomez

We award the Gunnar C. Isberg Student Scholarship to a student in planning or a related discipline who demonstrates academic, vocational and reputational excellence.

Edgar Leon Gomez, our 2023 scholarship recipient, is a master's student in the University of Minnesota Humphrey School's Urban and Regional Planning program. A student member of APA Minnesota, Edgar has excelled academically while serving as treasurer of the Humphrey Students of Color Association, being active with the Association of Pedestrian and Bicycle Professionals, and working as a transportation planning intern at Isthmus Engineering. In the latter role, Edgar has proved to be a ready contributor to whatever projects he's involved

with. His site visits across the state have helped him to learn the value of obtaining direct community input when planning out street redesigns.

As a Mexican-American and a member of the LGBTQ+ community, Edgar has a passion for ensuring underrepresented voices are heard and acted upon in planning, both from the community and within the profession itself. This, combined with his dedication to improving himself as a new planner and his enthusiasm for supporting his colleagues, makes us fortunate to have Edgar as a budding planner in Minnesota, and we're delighted to award him the Gunnar Isberg Student Scholarship to help him complete his planning education.



#### PEG AND OTTO SCHMID AWARD

#### **Sean Walther**

The Peg and Otto Schmid award is given to a mid-career planner who has demonstrated excellence in planning and a significant, positive contribution to the planning practice in Minnesota.

Sean Walther is an AICP-certified planner with 27 years of experience, much of which has been spent at the City of St. Louis Park where he is now the Planning Manager. Sean has worked diligently to promote racial equity, both in his efforts to shape the City's engagement processes to be more inclusive, and in his promotion of and membership on APA Minnesota's diversity, equity and inclusion committee. He has also led efforts to ameliorate the natural environment in St. Louis Park through the decade-long project to rewild Minnehaha Creek. As

both a team member and leader, he has participated in numerous projects to shape more sustainable local growth, provide transparency to the public, and ensure the new rapid transit line is paired with high-quality, transit-oriented development.

Sean has also volunteered and served as the Chair of the Minnesota Design Team, helping rural Minnesota communities to develop shared visions for improving their physical and environmental designs.

Those are just a few of Sean's accomplishments in his career thus far as a planner. As one of our awards jurors put it upon reading through his nomination, "Sean's mantra as a practicing planner seems simple: do what is right." Congratulations, Sean!







#### LIFETIME ACHIEVEMENT AWARD

#### **John Shardlow**

We give the Lifetime Achievement Award to an APA Minnesota member who has shown dedication and commitment to the field of planning, and who has impacted and advocated for planning throughout their career.

For 2023, it was our great pleasure to present this award to John Shardlow, FAICP. Over a career of 46 years, John has consistently championed environmental protection and planning education, in the process profoundly impacting planning in Minnesota for the better. A founding partner of Dahlgren, Shardlow, and Uban (DSU) in 1984, which eventually became part of Stantec in 2011, John retired as a Senior Principal at Stantec in the summer of 2023. Sustainable growth has been the hallmark of so many of John's projects, from the mixed-use, pe-

destrian-friendly Heart of the City development in Burnsville, MN, to the Central Corridor Transit Oriented Development Investment Framework for the LRT corridor between Minneapolis and St. Paul, and many other projects around the state. He has also volunteered for most of his career teaching educational workshops about planning and land use for appointed and elected officials, and since 2010 has served as a board member of the Minnesota Land Trust.

Through his kindness and tireless work at these and many other efforts, John leaves the planning discipline in Minnesota a much better place than he found it. For that, he was an easy choice for the Lifetime Achievement Award. Congratulations, John!









#### **EQUITABLE RESILIENCE BUILDER**

Increasing resilience to disasters and climate change is an increasing challenge for communities. The EPA's Equitable Resilience Builder (ERB) is an application that supports communities in resilience planning with a focus on equity. It engages users in a guided process to inclusively assess local hazards, equity, and the resilience of built, natural, and social environment systems. Results can be used to collaboratively prioritize actions to build community resilience in an equitable way.

The ERB is organized into five sections. Each section contains activities such as participatory mapping, storytelling, participatory indicator assessment, and action planning.


#### **GROWTH TREND FORECASTING**

For cities, having a declining population usually means socioeconomic and infrastructure challenges to accommodate the remaining population. Using population projections, this study in Nature Cities found that, by 2100, close to half of the nearly 30,000 cities in the United States will face some sort of population decline, representing 12–23% of the population of these 30,000 cities and 27–44% of the populated area. The implications of this massive decline in population will bring unprecedented challenges, possibly leading to disruptions in basic services. Although immigration could play a vital role, resource distribution challenges will persist unless a paradigm shift happens away from growth-based planning alone.

#### **RURAL MOBILITY**

A 2023 report by Smart Growth America explores the different ways that rural communities can adapt to thrive in a changing America, with a primary focus on active and multimodal modes of transportation. The presumption that living in a rural area inevitably means being dependent on a personal vehicle and driving long distances to access essential services negates the identities, experiences, and needs of the people in these complex and diverse communities. The more than 1 million rural American households without cars face unique barriers as alternate modes are not always accessible or affordable. Rural non-drivers—including older adults, low-income individuals, school-aged children, and people with disabilities—need independent mobility options to take advantage opportunities.

#### **PARKING REFORM**

For the past few years, Strong Towns has partnered with the Parking Reform Network to update an online interactive map of hundreds of cities in the United States and Canada that have undertaken parking reform.

Costly car parking mandates are required for housing and commercial uses in most North American cities and towns. Over the last century, these costly requirements have contributed to urban sprawl, lack of abundant and affordable housing, car dependency, and climate change. In recent years, however, many places have implemented reforms to these mandates, exempting new buildings from parking. Also check out the Parking Reform Network's related work, mapping the footprint of surface parking lots in 100 major cities.

#### VALUE CAPTURE TOOLKIT

The Federal Highway Administration's <u>Value Capture Techniques Toolkit</u> is a collection of resources for public and private entities interested in exploring value capture techniques as finance mechanisms for transportation projects. This Toolkit is based on research from the Center for Innovative Finance's Every Day Counts Initiative (EDC-5).

This Toolkit ultimately seeks to build a bridge from research to practice, leveraging the institutional knowledge developed by those that utilize such techniques to invite others to do the same. The toolkit and related resources can be accessed here.



#### **HOUSING AFFORDABILITY**

The National Housing Conference's <u>Paycheck to</u> <u>Paycheck (P2P)</u> database illustrates the ability – or lack thereof – of working families to afford typical housing in metropolitan areas across the country by comparing wage data and housing costs.

NHC updates the database every quarter to keep up with the country's rapidly changing housing market. In conjunction with these updates, they issue quarterly reports highlighting a different angle of the housing costs facing families across the country.
